

Candidate Facilitator Agreement.

The role of a Candidate Facilitator is by definition a position of trust with a candidate group. Because your Candidate Group is not yet recognized as a Congregation, this position occupies a liminal state between the Candidate Group and the Society of Congregations. You may be a member of TST as a whole, but have not yet secured the position of Congregant or Congregation Head.

Despite this intermediacy, the position of Candidate Facilitator is unambiguously a position of leadership within your group, and you are expected to conduct yourself as such. You will be expected to uphold the Tenets of TST and to adhere to the [TST Code of Conduct](#).

You and your members look to the Recognition and Onboarding committee for all contact with the SoC and have limited privileges within the Society of Congregations. During this onboarding process, your progress to recognition as a Congregation is overseen and evaluated by the ROC. Only when you have achieved every requirement to the satisfaction of the ROC will your Candidate Group become a recognized Congregation and a full member of the Society of Congregations.

By the time your Congregation is ready for recognition, the question of selecting official Congregation Heads will be addressed, and as Candidate Facilitator you will be among the leading candidates for the position. If you are selected to serve as Congregation Head, your candidacy as such will similarly be administered and evaluated by the Recognition and Onboarding Committee.

This role requires a significant investment of your time, efforts, and mental labor. By accepting this role, you are agreeing to the following:

1. You understand that you are held to a heightened standard of behavior, as you have a greater responsibility to your group than that of general membership.
2. You are expected to support your members in word and action, both online and offline, to better your group in positive ways. This is beyond organizing actions and events and activities, it also means discouraging gossip, "flame wars", and trolling by and among your membership.
3. You agree to follow the [Code of Conduct of TST](#) and be held accountable to it.
4. You understand that until your Congregation is a recognized member of the SoC it does not enjoy the privileges or protections of the SoC and does not represent The Satanic Temple. In anticipation of admission into the SoC, you and your members should behave in ways that reflect positively on TST.
5. You understand that the ROC has been tasked with their role by the Society of Congregations, and that the duties, tasks and procedures of the ROC are legislated by the SoC. To this extent, the ROC represents the SoC to all Candidate Groups.
6. You understand the ROC has been tasked with onboarding Congregation Heads and have sole authority and responsibility to do so. You will only be a Congregation Head if the ROC determines you are qualified. If the ROC rules that you have not qualified for leadership you will accept that ruling and follow the guidelines provided to you and to your Congregation or Candidate Group by the ROC.



7. You understand that this is a process that requires time and effort. You agree to work with the ROC, with the CROW if provided, and to rely on your own group's council or leadership team. You will work out a regular meeting schedule for your onboarding team and to remain in contact and regular conversation. You will be ready to accept advice and suggestions, and also be willing to ask for support where needed. The ROC wants you to succeed and will help.
8. You accept the challenges ahead of you freely, understanding they are complex, with the goal of successfully joining the Society of Congregations of The Satanic Temple.
9. You agree that you will make regular use of the SoC Candidate Group Facebook Group in order to keep in touch with the ROC, CROWs, and your Facilitator peers, unless the ROC approves other shared communication methods.
10. If you wish to create a Discord, Slack, or similar platform outside of the provided Facebook Group, you agree to obtain ROC approval and grant admin access to your ROC and/or CROW Representative.
11. If at any time you decide to vacate the position of Candidate Group Facilitator, you will cooperate with making the groups' resources available to its new leadership.
12. You may not form a legal entity/business for your group until it has been approved as a Congregation. Once approved, the Congregation's legal entity/business may not be incorporated with "The Satanic Temple" in its name. You may, however, file an "Assumed Name" or "DBA" or the equivalent in your State or Country for your legal entity/business that includes "The Satanic Temple" in its name. (As an example, your legal entity/business might be registered as "666 Ministries" with your State and you file an Assumed Name as "The Satanic Temple Peoria".)
13. Merchandise can only be sold with approval by the ROC. This will be done on a case by case basis which will vary due to local differences in laws and regulations. You must have a legal mechanism for handling local sales taxes and business/sellers requirements, which is your responsibility to manage without formation of a legal entity. You must be able to demonstrate the ability to comply with this requirement by researching and compiling source material to the ROC's satisfaction from your local jurisdiction that outlines its applicable rules and how you are in compliance. The ROC maintains no liability for any non-compliance with respect to local laws by your group.
14. No cash donation collection for external entities outside of approved qualifying event or in conjunction with the Good Works, the Satanic Representation Campaign, and other TST Campaigns.

The process of building a Satanic community comes with many challenges. The ROC has procedures and experience to help you through it. We look forward to working with you.

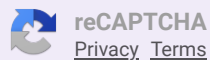
